The Jackson County Master Gardener™ Association (JCMGA) is a non-profit volunteer organization affiliated with the Oregon State University (OSU) Extension Service. The purpose of the Master Gardener™ Program is to enhance and supplement the OSU Home Horticultural Program and to promote gardening education within the community. JCMGA has budgeted funds to promote gardening in Jackson County schools for the 2017-2018 school year.

The purpose of these funds is to encourage interest and education in gardening through the use of hands-on gardening materials, supplies, and small tools in implementing garden projects. Funds are **not** intended for large, more costly items such as greenhouses, rototillers, or hardscape.

JCMGA offering an opportunity to Jackson County schools to apply for funds to supplement beginning or existing garden and horticultural programs. All Jackson County schools preK-12 may apply. An evaluation process will review all submitted applications, and distribute funds according to availability and benefit to your students and others across Jackson County. Be advised that funding is limited; not all projects may be funded. The 2017-2018 school year application deadline is October 13, 2017.
